Mayor Argumedo called meeting to order at 5:03 p.m. in the Council Chambers.

APPEARANCES AND PRESENTATIONS

1. <u>Certificate Honoring the 2017 and 2018 Girl Scouts for Earning the Silver</u> <u>Award</u>

Mayor and Councilmembers issued Certificates honoring the 2017 and 2018 Girl Scouts for Earning the Silver Award and recognized entire Girl Scout Group for their contributions to the community.

2. <u>Commendation Honoring Rodrigo Gallegos for his Many Years of</u> Dedicated Service to the City of Commerce

This item was moved to a later date.

PUBLIC COMMENT

Tommy McLeland complaint about the noise level of the library and air conditioning being too cold. Ms. McLeland also asked that the City Council deals with homeless issues and help those in desperate need.

Carlos Grajeda, Terry Westmore, Evelyn Diaz, and Charles Springer spoke on behalf of the City of Commerce Association. Mayor Argumedo spoke about Council responsibility to balance the budget and provide programs and services for the community, and continue those programs for future generation, which would require fiscal accountability.

Councilmember Altamirano moved, seconded by Mayor Pro Tem Soria, to adopt . The motion carried by the following vote:

8. <u>Confirmation of 2017-2018 Weed Abatement Charges</u>

Director of Administrative Services and City Clerk Shumway provided an overview of the staff report. Mayor Argumedo opened Public Hearing. There were no individuals wishing to address the City Council. Mayor Argumedo closed Public Hearing.

Tem Soria moved. seconded Councilmember Mavor Pro by Rebollo. to confirm the 2017-2018 Weed Abatement Charges as recommended bv the Los Angeles County Agricultural Commission. The motion carried bv the following vote:

SCHEDULED MATTERS

9. <u>Committee and Commission Appointments</u>

Mayor Argumedo appointed Johncito Peraza to Planning Commission There was a consensus among the City Council to appoint Mary Ann Griego-Tally as an ex-officio member of the Measure AA Advisory Committee. Mayor Argumedo appointed Yoli Acosta to Traffic Commission.

10. <u>Presentation on Commerce Bike and Pedestrian Master Plan</u>

Public Works and Development Services Director Babaki provided an overview of Carlos Velasquez, KOA Consulting, provided a presentation the staff report. regarding bike routes plan in the City and Safe Routes to School project. Discussion took place on how to connect bike path to riverbank and other areas in Mr. Velasquez stated that this is included in the plan. Councilmember the Citv. Mendoza recommended taking into account upcoming projects before installing any bike path or connectivity since Gold Line project is going to be coming to the City and also coordinate with City's pavement plan in order to eliminate duplication. Further discussion took place on how to interconnect bike path of several neighborhoods, and how this projects is going to be funded, and implementation. Mayor Argumedo recommended lookina into possibilitv of providing bike racks for residents in order to get their bicycles to bike paths.

11. <u>Fitzgerald Avenue - Rosini Community Survey Results</u>

Public Works and Development Services Director Babaki provided an overview of the staff report.

City Council

Discussion took place regarding results and based on that majority of residents want something to be done to alleviate the problem. Councilmember Rebollo cautioned about some of the actions because when Community Service Officers were stationed in the area to control the traffic as a result of that it created a problem Village neighborhood. Councilmember Altamirano recommended in implementation of the drive permit parking. Councilmember Soria spoke about resident responsibility to clean the drive in, and eliminating inoperable vehicles. lt was a consensus among the City Council to direct staff to analyze this issue more and try to come up with something to address the problem.

12. <u>Residential Refuse and Recycling Rate Increase and Agreement Term</u> <u>Extension</u>

Deputy Director of Public Works Operations Nila provided an overview of the staff report.

Discussion took place, and there was a consensus among the City Council to authorize a 5% increase, but look into four year contract versus five year contract in order to align it with the commercial refuse and recycling agreement terms.

Councilmember Mendoza moved, seconded by Councilmember Altamirano, to adopt resolution authorizing a rate increase of 5% and extend contract for four more years a term extension ending June 30, 2023. The motion carried by the following vote:

13. <u>Consideration for All-Way STOP at Ferguson Drive & Gaspar</u>

Public Works and Development Services Director Babaki provided an overview of the staff report. Discussion took place about safety hazards posed on that intersection. There was a consensus among the City Council that the stop sign is warranted to ensure the safety of stakeholders. Further discussion ensued.

Councilmember Rebollo moved, seconded by Councilmember Mendoza, to authorize the installation of all-way STOP at the intersection of Ferguson Drive & Gaspar Avenue. The motion carried by the following vote:

14. Installation of Artwork at 5770 South Eastern Avenue

Deputy Director of Development Services Marquez provided an overview of the staff report. Discussion ensued. Deputy Director Marquez stated that cost of the

artwork is \$15,000 and the developer pays it in full. Discussion took place about the location of the artwork. Deputy Director Marquez also stated that if the developer does not choose the artwork, funds go to a special fund that the City Council could use for future artwork.

Councilmember Rebollo moved. seconded by Councilmember Altamirano, installation adopt Resolution approving the of artwork at 5770 South to Eastern Avenue pursuant to the City's Art in Public Places program. The motion carried by the following vote:

15. <u>Presentation on Proposition 64, the Medicinal and Adult-Use Cannabis</u> Regulation and Safety Act

Mayor Argumedo announced a break at 8:12 pm. Councilmember and the Mayor returned from the break at Returned at 8:26 pm.

Assistant City Attorney Copado provided an overview of the staff report. Discussion took place on including the community, having educational component to this topic, and make a decision once all stakeholders input received. Councilmember Rebollo recommended that if the City decides to allow cannabis in the City, money generated should be allocated towards specific City programs like youth, seniors, veterans, etc.

Further discussion took place regarding outreach, town hall meetings, stream outreach live through Facebook.

Councilmember Soria suggested that they could look into option three as recommended by the Assistant City Attorney Copado while the outreach is conducted.

Mayor Pro Tem Soria moved, seconded by Councilmember Rebollo, to adopt Go ahead of recommendation #3 and include the community outreach and include empirical evidence of works and what does not work. . The motion carried by the following vote:

16. <u>Update on City's Pension Status</u>

Finance Director Domic provided an overview of the staff report. Discussion took place regarding increasing cost for pension fund and increasing costs. It was a consensus among the City Council that this is a serious problem that the City will

be facing and that the Council has a responsibility to allocate money wisely, protect the services. It was stated that the City wants to provide competitive salaries and benefits to the employees, but the Council should be responsible for the entire City and protect existing services for the residents.

Councilmember Rebollo spoke about possibly establishing social media etiquette for elected officials and warned about posting information on social media that could offensive for certain groups of people.

Councilmember Mendoza reported that he attended Fourth of July celebration, ICA Summer Seminar, and meeting in Bristow Park area. Councilmember Mendoza spoke with the Mayor of Downey and got some ideas from him that the City of Commerce could implement.

Mayor Pro Tem Soria reported that he had a great family time at Camp Commerce.

Mayor Argumedo complimented staff on a great job done for Fourth of July celebration and reported that he attended the ICA Summer Seminar.
