Mayor Pro Tem Soria called meeting to order at 5:07 p.m. in the Council Chambers.

PUBLIC COMMENT ON CLOSED SESSION ITEMS

James Casso, Attorney for the City of Industry, spoke regarding item #2 on Closed Session agenda. Mr. Castle stated that the property is a Successor Agency property of the City of Industry and currently under legal agreement and opposed that acquisition.

Konradt Baltlam, City Manager for City of Chino Hills, stated that the letter of opposition was submitted for Council consideration. The majority of the property identified under item #2 on Closed Session agenda is located in the City of Chino Hills, and stated that that acquisition should not be pursued due to several reason identified in the letter submitted.

PUBLIC COMMENT

James Herman, Commerce Resident, had a concern regarding the cannabis informational/community meetings not properly advertised and how information was gathered for the surveys that consultant was referring to. Mr. Herman asked that cannabis operation in the City of Commerce is placed on the ballot.

Mr. Callenas opposed cannabis operation in the City of Commerce.

Derek Davis, representing one of the cannabis applicants, questioned why the application process was scheduled in such a rush, and asked to re-evaluate the applications, and consider allowing other businesses to operate in the City of Commerce.

Sharon Basic stated that she brought up issue of people not stopping at the Village Drive at the stop sign and asked that the proper enforcement is done.

CONSENT CALENDAR

Director of Administrative Services and City Clerk Shumway requested that items #12 and #14 are tabled to a later date and Item #13 being discussed in the open session. Councilmember Mendoza requested to pull item #6 for discussion.

Director of Administrative Services and City Clerk Shumway provided an overview of the staff report. Director Shumway stated that it is recommended to close City Hall from December 24, 2018 to January 2, 2018, and for those full-time employees affected by the closure to authorize two days off for Monday December 24, 2018 and December 31, 2018. For the rest of full-time employees scheduled to work on Mondays, it is recommended to approve half a day on Monday December

24, 2018 and half a day on December 31, 2018. City Administrator Cisneros recommended approval of the City Hall Closure contingent on the Employee Association approval.

Councilmember Altamirano moved, seconded by Mayor Pro Tem Soria, to adopt The City Council will consider approval of the City Hall Holiday Closure for a week from December 24, 2018 through January 1, 2019.. The motion carried by the following vote:

15. City of Commerce - Bureau of Gambling Control Issues

Finance Director Domic provided an overview of the effects should the regulations for Casino change. Discussion took place, and the entire Council spoke about looking for other avenues in order to increase revenue, and bringing more development and business to the community to overcome budget shortfalls. There was a discussion about finding constructive solutions, diversifying revenue, and about unity of the Council in order to complete and execute projects that are in process right now.

Mayor Argumedo stated that the City of Commerce presented 700 letters at the meeting with Gaming Commission, which was a powerful tool in addition to all testimonies and personal storied.

No action was taken on this item. It was informational item only.

16. Approval of Traffic Control Plan and Authorization of Temporary Street Closures for the Citadel Outlets' 2018 Black Friday Sales Event

Public Works and Development Services Director Babaki provided an overview of the staff report. Deputy Director of Engineering Yang presented a proposed plan for traffic control during Black Friday at the Citadel. Discussion took place about Fitzgerald street and other neighborhood streets be barricaded in order to stop shoppers to park on those streets. Councilmember Soria recommended developing a better traffic plan for Mix Master, and possibly doing manual traffic

control by creating dedicated lanes for turn lanes. Councilmember Soria recommended to utilize CSO for traffic control and utilize security/retired officers instead of Sheriff's to reduce costs.

Councilmember Mendoza Councilmember moved. seconded Altamirano, by Resolution approving the traffic control plan and authorizing closures Hoefner **Flotilla** temporary street along Avenue, Street. and Camfield Avenue for the Citadel Outlets' 2018 Black Friday Sales Event. The motion carried by the following vote:
