CALL TO ORDER

Mayor Argumedo called regular City Council meeting to order at 6:17 p.m.

Human Resources Director Pappo led the Pledge of Allegiance

INVOCATION

Councilmember Mendoza offered the invocation.

APPEARANCES AND PRESENTATIONS

1. Welcome and Introduction of Sheriff's Captain Ernest Chavez

Council and the Mayor welcomed Captain Chavez as new East LA Sheriff's Captain.

 <u>Commendation Recognizing the Department of Public Works and</u> <u>Development Services for Earning the City 2018 Project of the Year Award</u> for the Washington Boulevard/I-5 Freeway Project

Mayor and Councilmembers recognized Public Works staff for receiving the City 2018 Project of the Year Award.

PUBLIC COMMENT

Laura Logan, President of CCEA, opposed approval of item #9 and item #10. Ms. Logan stated that bachelor degree requirement is not necessary and opposed condensing two positions into one. Ms. Logan also asked that negotiations teams become serious about Union contract that is already expired.

Christine Dimas, Montebello Unified School District, spoke about conflict of interest for City Administrator being a Montebello School Board Member.

Gloria Nezahualcoya asked that the "no parking" signs are expedited in order to proceed with homeless efforts.

Richard Hernandez spoke again about better notification of businesses and residents about new businesses coming to Commerce.

CONSENT CALENDAR

Councilmember Rebollo asked to pull item #9, and Councilmember Mendoza requested to pull item #10 for discussion.

Item #9- In response to Councilmember Rebollo of why there is opposition to bachelor's degree, Laura Logan responded that some positions at that same level do not require bachelor's degree and that requirements should be consistent with similar positions.

City Administrator Cisneros stated that staff wants to be consistent. Councilmember Rebollo stated that it was past practice of not requiring degrees for positions in higher range, but moving forward the City should relook those positions, and have that requirement added.

Following discussion Councilmember Mendoza recommended waiting for class and compensation and decide at that time.

Councilmember Rebollo moved, seconded by Councilmember Mendoza, to adopt resolution amending th Classification and Compensation Plan by revising the classification specification for the Head Travel Sports Coach classification. The motion carried by the following vote:

Item #10- City Administrator Cisneros stated that classification was changes as there were no candidates qualified. Staff identified more general description and this proposed model would work better. Discussion took place. It was suggested to making it a seasonal position dues to the fact that there are so much downtime in the camp, however, having a full-time individual would allow utilizing that position for City Hall special events.

Further discussion took place regarding not combining two positions into one, and also giving everyone fair chance to apply for the position.

Mayor Pro Tem Soria moved, seconded by Councilmember Mendoza, to approve revisions to the personnel classification and compensation plan by amending the Camp Program Manager classification, revise job description and salary level for this classification. Associate Planner Molinar-Esparza provided a brief overview of the staff report. Discussion ensued about Home Preservation program, and restrictions associated with CDBG funding.

Councilmember Rebollo moved, seconded by Mayor Tem Soria, Pro to adopt Resolution authorizing the allocation for the 45th year of Community Development Block Grant (CDBG) funds for Fiscal Year 2019/2020. The motion carried by the following vote:

13. <u>A Presentation by the United States Census Bureau Regarding the</u> Upcoming 2020 Census

United States Census Bureau Representative provided a presentation about census, outreach and efforts to engage the community.

Discussion took place about mistrust and fear in the community. However, it was stated that the Information is protected by law and there was no breach of information received in the past. Following discussion, it was recommended that United States Census Bureau hires local people in order to get better response from residents.

14. <u>2019 Youth Education and Service (Y.E.S.) Leadership and Mentoring</u> Program

City Administrator Cisneros provided a brief overview of the staff report. Councilmember Discussion ensued. Rebollo recommended to incorporate interview process for these hires, and provide workshops for all Y.E.S. workers. Discussion took place to allow all youth who apply to get the experience. Following discussion. it was decided to advertise. collect applications and if more than 80 applications received, staff will bring back this for Council decision and allocation of additional funds.

Councilmember Mendoza moved, seconded by Councilmember Rebollo, to approve the 2019 Commerce Summer Youth Education and Service (Y.E.S.) Leadership & Mentoring Program beginning July 1, 2019 and to increase funding for 85 participants. The motion carried by the following vote:

Director of Administrative Services and City Clerk read the title of the ordinance. The motion carried by the following vote:
