Item #14 - Parks and Recreation Director Lipton provided a brief overview of the staff report.

Discussion took place regarding new organization Model City Cancer Fighters that was added to the Civic Organizations recommended list. Discussion took place whether Model City Cancer Society is associated with the Relay for Life, and what happens to the funds collected from fundraiser.

Councilmember Rebollo moved to approve Civic Organization of the City of Commerce for the 2019 calendar years as recommended by the Parks and Recreation Commission, except Model City Cancer Fighters.

Councilmember Mendoza stated he that was in support of approving organizations as recommended. Mayor Pro Tem Soria Councilmember and Altamirano agreed with Councilmember Rebollo that thev would need more information about the new proposed organization. Mayor Argumedo recommended that Councilmembers not politicize this matter.

Kerry Jenkins, Economic Development Manager for County of Los Angeles, and Emily Kadia, who is part of team who oversee the program, provided presentation regarding Smart Funding program available for small to medium size businesses. Alternative Update and Support of the Washington Blvd Alternative for the

City Administrator Cisneros stated that the City Council even supporting ir

concept, did not officially approve resolution supporting the Washington Blvd alternative for the Eastside Transit Corridor and recommended that the City Council authorizes staff to coordinate with the Gold Line Washington Boulevard cities to advocate accelerates start dates for each project.

Discussion took place that in the past there was an opposition to the project from business community, however, since the different alternative was selected, the City in support of the proposed alternative. Discussion took place whether East Los Angeles will be in support of the Washington Boulevard alternative.

Councilmember Mendoza moved, seconded by Mayor Soria. to Resolution supporting the Washington Blvd alternative the Eastside Transit Corridor, and authorizing staff to coordinate with Gold Line Washington Boulevard cities, corridor cities and business communities and organizations to advocate accelerated start dates for each The motion carried by the following vote:

Finance Director Domic provided an overview of the staff report.

Discussion ensued about the Bristow Park plumbing repairs, Bandini Park plumbing repairs, and Bristow Park kitchen repairs. Councilmember Rebollo recommended that the City considers replacing Bristow Park kitchen cabinets instead of refurbishing.

Councilmember Rebollo moved. seconded by Mayor Tem Pro introduce Ordinance of the City of Commerce Amending Chapter 2.04 (City Administrator) to change the title of the City Administrator to City Manager City Manager with responsibilities assign the and authority consistent with cities that have a council-manager type of government, read the Ordinance by title only. **Director of Administrative Services** City Clerk read the title of the Ordinance. The motion carried by the following vote:
