Zoning Text Amendment (Citywide) – Development Standards for CPF Zones

Contract Planner, Knarik Viscarra, presented this item to the Commission to consider a Zone Text Amendment to amend Table 19.13.030A (Development Standards - Public Facility Zone) of the City of Commerce Municipal Code to increase the floor area ratio and height limit for properties zoned Commercial Public Facility and are not adjacent to residentially zoned properties. She informed them that the proposed amendments will be applicable citywide.

Zoning Text Amendment (Citywide) – Home Occupation Permits Contract Planner, Knarik Viscarra, presented this item to the Commission for approval to change the review authority for Home Occupation Permits, and provide clarification on the applicability of Home Occupation Permit and the uses considered appropriate for such permits. Current Commerce Municipal Code Section 19.39.820 (Initiation) and 19.39.830 (Proceedings) will be replaced in their entirety with 19.39.820 Authority and 19.39.830 Applicability. The proposed amendments will be applicable citywide.

The Commission expressed some concerns and asked some questions of staff. Discussion ensued.
