2. Update on Commissioners Request for City of Commerce Crime Statistics

Sheriff's Sergeant Hernandez gave Commissioners a report that is updated for the previous month. Stats are compared to the previous year. He explained the report. Citadel crimes dropped 7%. Deployment is only discussed with the City Manager and Council. The COPS Team is assigned when high crimes are occurring. Vice-Chairperson Viesca requested a breakdown of crimes in the residential areas.

Council will assess if there is a need for a Director.
