PUBLIC COMMENT

Camila Cadenas, James Herrmann, and Alma Suarez spoke in opposition to cannabis.

Stacey Wang, Legal Counsel for Holland & Knight, stated that the law firm represents the applicant and spoke in support of upholding the Planning Commission decision to allow Trojan storage and deny the appeal.

Ann Arnow stated that the only comparable city that has 28 cannabis operators is the City of Carpentaria. Based on her research, there are severe issues in the community with the odors and smells from these types of businesses.

Carl Baker stated that he was running for Councilmember seat for March 3, 2020 election, opposed cannabis operations in the City and spoke about corruption.

Richard Hernandez spoke in opposition to cannabis.

Ofelia Avila announced that she was running for councilmember seat for March 3, 2020 election, and opposed cannabis operations in the City.

Dave Rodriguez spoke about crime rates in Commerce.
