PUBLIC COMMENT

Director of Administrative Services and City Clerk Shumway read the following comments for the record:

Lori Miles asked that the City Council allows all employees vote on the new agreement with the Union regarding the reductions.

Desiree Pedraza and Charlotte Lopez spoke in opposition of the agreement and also not allowing reduction in pay for essential employees like Transportation Department employees and Community Service Officers.

Laura Logan, President of Employee Association, spoke in support of the agreement.

Councilmember Soria asked to pull item #4. Councilmember Soria recused himself from the discussion or vote on this item due to the potential conflict of interest.

Mayor Pro Tem Rebollo moved, seconded by Councilmember Argumedo, to adopt Resolution awarding the Traffic Interconnect Systems Upgrades Project, and award a construction contract to Elecnor Belco Electric, Inc., for the Traffic Interconnect System Upgrades Project, and authorize Transtech Engineers, Inc. to proceed with construction management and inspection services. 7. <u>Commerce in Motion Comprehensive Operational Analysis Project</u>

Transportation Director McFerguson introduced Hazel Scher and Peter Soderberg, Transportation Planners with Nguard and Associates. Mr. Scher provided a presentation and stated that the company conducted a comprehensive analysis and took a report of every angle of bus operation in Commerce, and came out with the recommendations on how to improve the services.

Discussion took place regarding revising some routes and eliminating some loops by making more directional routes to reduce travel time.

Transportation Director McFerguson stated that there was much feedback received from areas that need improvement. Ms. Scher concluded that this was the

evaluation stage, and they would begin the recommendations phase, obtain more input, and provide a comprehensive final report in winter 2021. No action was taken on this item. it was informational only.

8. Letter of Agreement Between the City of Commerce and City of
Commerce Employee Association Related to the Impacts of the
COVID-19 Pandemic on the City's Economic Condition and Loss of
Revenue

City Manager Cisneros provided an overview of the staff report and stated that the Letter of Agreement extends the Agreement with the association until 2023, and reductions are uniform for full-time employees as well as part-time employees with seven percent of PERS pick up and raise of seven percent will be eliminated. Discussion took place, and the Councilmembers stated that this was not an easy decision but it was a collaborative decision, thanked employees for the patience.

Councilmember seconded Argumedo moved. by Councilmember to adopt resolution approving the letter of agreement between the City of Commerce and the CCEA related to the impacts of the COVID-19 Pandemic City's economic condition and sudden loss of critical the severe on revenue. 9. Recreational Vehicle (RV) Parking Permit Program Policy

Director of Public Works Hernandez provided an overview of the staff report.

The discussion took place. According to Director Hernandez, no parking signs will be installed this week, and staff will continue the outreach campaign in order to inform the residents. This outreach campaign would include leaving flyers on the RVs as well as spreading information via social media. Enforcement of the RV parking would begin September 1, 2020; however, the implementation for those who reside in RVs and not residents is on-going for no overnight parking on certain City streets.

Councilmember Mendoza recommended using digital signs and place those around the City in order to inform residents about the upcoming enforcement.

Councilmember Argumedo moved, seconded by Councilmember Mendoza, to approve the Recreational Vehicle (RV) Parking Permit Program Policy.

Director of Economic Development and Planning Jimenez provided an overview of the staff report.

The discussion took place about the parking requirements and whether this new legislation would affect current conditions that the City has in place.

There was one recommendation specifically discussed to allow for a wider driveway in order to get cars from the streets, and instead utilize the driveway at the houses. Director Jimenez stated that he would review the Municipal Code and present recommendations at a later date as it relates to parking requirements.

Mayor Altamirano opened Public Hearing. There were no individuals wishing to address the City Council on this item. Mayor Altamirano closed Public Hearing.

Mark Murray, the Special Counsel, provided a couple of clarifications regarding JADU, which would only qualify with the single-family unit.

Councilmember Argumedo moved, seconded by Councilmember Soria. read by title only and introduce for first reading an Ordinance Amending Commerce Municipal Code. 19 (Zoning), 19.07 (Residential Title Chapter Section 19.07.090 (Second Zones). Units) and Replacing with Section 19.07.090 (Accessory Dwelling Units and Junior Accessory Dwelling Units). **Director of Administrative Services** and City Clerk read the title Ordinance. The motion carried by the following vote:

Mayor Pro Tem Rebollo moved, seconded by Councilmember Soria, to read **Ordinance** by title only and approve for first reading an 19 (Zoning), Commerce Municipal Code, Title Chapter 19.39.740 regarding the intent and purpose of the temporary use and special use permits and expand applicability to aide in assisting existing business and generating new business during emergency situation and adopt Categorical Exemption under the provisions of the California Environmental **Quality Act** Director or Administrative Services and City Clerk Shumway read the title of the Ordinance. The motion carried by the following vote:
